 - * Policies include **Heat and Extreme Weather, Dog Health & Inclusion, Lending, Payment and Refund policies**

The committee will not accept responsibility for any accident, loss or damage to any person or property.

Bitches in season are not permitted to attend class. Dogs are welcome to attend our classes from the age of 6 months, but must be fully vaccinated and have a basic understanding of commands.

Dogs must be always on lead or under effective control.

To be eligible for membership, your dog(s) must have current vaccination. Evidence of this **must** be attached to your application form. Titre test results will be considered upon a statement from your veterinarian.

Members are responsible for advising the Membership Officer of any change of details (address, email, phone, etc.)

Fees:

- Membership fees are \$50 per person, per annum. A **once only** \$20 joining fee for new members is applicable.
- For non-Dogs Victoria members, an insurance levy of \$9.30 is payable - per person, per annum.
- **An additional fee (\$5 class, \$5 ring use, or \$10 private trainer lesson) is applicable and paid prior to each attendance.**

Membership fees are to be paid annually and are due in January each year.

The Membership period is from 1 January to 31 December of each year.

If membership is applied for after the 30 June, 50% of the annual membership is to be paid.

Membership fees are not transferable and cannot be refunded.

All Melbourne & District DWD Club events are carried out in accordance with the current COVID safe guidelines.

Training

Melbourne & District Dances with Dogs Club Inc. trains using positive reward-based methods.

Only soft collars, haltis and harnesses are permitted. Check chains, prong and electric collars are **strictly** prohibited.

Dogs wearing yellow scarves/coats should be given plenty of space and not be approached by other members or their dogs.

What to bring – training treats/toys, mat or crate.

Venues – **DANDENONG** - The Poultry Pavilion, Dandenong Showgrounds, Greaves Reserve, Bennet Street, Dandenong.
BULLA – Dogs Victoria Exhibition Centre, Uniting Lane, Bulla.

NB. Please advise your Trainer prior to attending if your dog suffers anxiety, sensitivity, or any form of aggression. Most dogs can be accommodated but some may be deemed unsuitable for class participation or may not be permitted to attend some events.
